## FIRST LUTHERAN CHURCH – ANNUAL MEETING MINUTES – 2/14/2021

Meeting was called to order and an opening prayer by President Archie Barriage at 9:30am. Total attendance was confirmed with 122 members and quorum was reached.

Agenda approval: The annual meeting agenda was presented and reviewed. Hearing no objections, concerns or questions, agenda was approved as presented.

2020 Minutes: The minutes from the 2020 annual meeting were presented and reviewed. Hearing no objections, concerns or questions, the minutes were approved as presented.

#### Old Business: no report

## Reports:

Financial & Audit Report – Gary Peters, chair of the Board of Trustees, presented the 2020 financial report. Overall, the 2020 year of uncertainty ended well financially. Celebrating that the mortgage debt has been paid in full! Total income \$1,014,931.89 for the year included the \$152,965.71 of fundraiser income for debt elimination and \$91,500 from PPP (payroll protection program) loan forgiveness. Giving contributions decreased in 2020 vs 2019, however expenses were down as well due to how worship was being held. We did basically break even financially. Audit report was conducted and found acceptable. Opened for questions. Presented questions were addressed. Hearing no additional questions, concerns or objections, the 2020 financial report was approved as presented.

Nomination Committee & Election - Katie Furman, chair of the nomination committee, presented 2021 ballot on the list of candidates who have been nominated and agreed to serve in the following capacities. (see annual report 2021 ballot). Each vacancy has been filled. Hearing no objections, concerns, or questions the proposed slate of candidates is approved unanimously.

2021 Budget – Budget was presented by Gary Peters. Discussion on how budget numbers were gathered due to the 2020 year and part of the 2021 year being less than normal. On a conservative approach, budget team went back to 2019 actual year of income. WE have paid off the mortgage! This is a huge help to our budget and allows us to do some additional things not otherwise able. There are a few new staff positions in the budget and also a need for some additional technology and additional benevolence. Questions from several members were addressed. Hearing no additional questions, concerns or objections the presented 2021 budget was approved.

Vision Report: Pastor Perry discussed the vison report and how we will continue to move forward with some of the dreams and ideas that were presented from this team. Doing some updates to the Drive-in Worship will likely be the first step. Vision document will be provided for review.

## Other Business:

Recognition of Staff, different church Boards and a special recognition of those who have served as volunteers and who are leaving a board position. – Special thanks to all of you! Closing prayer, meeting adjourned at 10:33am.

## FIRST LUTHERAN CHURCH – SPECIAL CONGREGATIONAL MEETING MINUTES – 12/5/2021

Meeting was called to order at 9:50am by President Cindy Redmond (newly elected President to serve Archie Barriage remaining term) Total attendance was confirmed with 139 members (108 in person, 31 on-line) and quorum was reached.

President Cindy welcomed all to the meeting and presented the order of meeting.

Prayer: Pastor Brian said opening prayer.

Project Presentation: Pastor Perry presented the columbarium project. He provided information regarding what a columbarium is, why it would be important to our congregation, who would have access ability, basic project cost, when project would begin and where "Three Cross Memorial Garden" would be located. Additional features such as the memory band and scattering lawn were also presented.

Bob Brown and John Adams provided additional information regarding the set-up of the columbarium and future for grounds maintenance and additional placement as needed.

Floor was opened to congregation for additional questions and discussion. After all questions were answered and no hearing no additional discussion.

Motion: Bob Brown made a motion, First Lutheran Church shall establish an on-site columbarium on the north side of the church and form a committee to oversee the columbarium. John Adams, SR seconded motion.

Floor was opened back up for any discussion or questions regarding said motion, non to present.

Ballots were distributed for vote. Vote: Ballots were collected, and results presented. Total of 139 votes presented: 136 yes, 3 no, motion passed. (108 in person, 22, text message, 8 email, 1 Facebook = 139 total votes)

Motion to adjourn meeting by Kim Wermersen, second received, carried.

Meeting adjourned at 10:41am.

Dear First Lutheran member,

Grace and peace...and perseverance to you as you take the time to read these annual reports! I trust my colleagues and fellow staff members will share financial details, growth statistics to celebrate, and growing edges the last year brought to us. May I share a few unmeasurable insights with you?

During Pr. Perry's sabbatical I learned of the number of leadership and staffing conversations that are needed on a weekly basis and the direction that the congregation seeks on a regular basis from Pr. Perry. I also quickly got a better understanding of the gifts of our staff and leadership boards and came to utilize them and their feedback frequently. We have a strong team of leaders that helped to guide us through the ongoing changes as we sought to transition to more in person meetings. Our staff, custodians, and leadership teams especially shined when we had a flood in the ed. wing. Every one of them, yes, every one helped get it fixed properly.

All this left me free to do the things I love doing the most with this congregation – preaching the good news, offering pastoral care, and even fitting in a class over zoom during that time. There is no one too good to need Jesus. No one too sinful to be forgiven. No one is beyond His ability to help, nor is anyone ever so secure as to not need his help. ## 2021-WHAT A YEAR FOR FIRST!

With the help of God, a loving and giving spirit, and the dedication to spread the gospel of Christ throughout the Lakes Area, the First Lutheran Church Family made many milestones during 2021!

- On December 30, 2020 our 5.6 million dollar mortgage on our buildings and grounds was fully paid off! We celebrated this event Sunday, June 27, 2021 with a service of praise and thanksgiving at our Drive-In Worship service, and burned the mortgage! Because the mortgage was paid off 7 years early, First Lutheran saved \$462,803.00 in interest payments. This debt being erased has enabled First to undertake many spiritual and mission projects for 2021 and beyond!
- The second milestone was the fund drive to pay for a new Drive-In Worship Center on our campus. The fund raising effort went from May 20-September 7, 2021 with giving coming in throughout the fall. Over \$247,000.00 (a quarter-million) was donated, with gifts coming from First members as well as visitors and friends from a four-state area! Construction on our new worship center is set to begin on or around April 1st, with a tentative opening set for early summer 2022. Sincere thanks to all who supported this tribute to the ministry (71 years) of the Drive-In Worship Center!

## 2021 ANNUAL REPORT - BOARD OF TRUSTEES

The Board of Trustees met on a monthly basis during 2021 to tend to the financial affairs of the Church. The primary duty of the Board of Trustees is to guard and protect the financial resources of First Lutheran and monitor the use of those financial resources in a responsible and prudent manner and in ways which serve God and the members here at First Lutheran, the people in the immediate surrounding area, and the people of God throughout the world. The Board of Trustees has five sub-committees -- Buildings and Grounds, Missions, Stewardship, Foundation, and Budget. The Trustees Board is comprised of five elected members, four officers (President, Financial Secretary, Treasurer, and Secretary), and regular attendance by Pastor Perry and Val Watters, bookkeeper.

The 2021 elected members were Bruce Nystrom, Wayne Schutte, Sara Frerichs, Amanda Titterington, and myself as Chairman. Others attending were Archie Barriage and Cindy Redmond, Presidents, Pat Holdorf, Treasurer, Bob Brown, Financial Secretary, and Mickey Harrington, Recording Secretary. Pastor Perry also attended on a regular basis and Pastor Brian as needed. The group worked diligently, took their responsibilities seriously, and were truly a pleasure to work with.

The total receipts for the operating budget for 2021 were \$804,089. The actual expenses for 2021 were \$761,049. This resulted in excess receipts over disbursements of \$43,040.

Thanks to all of you who assisted in achieving this budget surplus.

Highlights for 2021:

- Assisted in budget items related to the new Drive-In worship facility to be constructed in 2022.
- > Commenced discussions related to a new salary package for a potential new Youth Minister.
- Accomplished the forgiveness of the debt related to the Payroll Protection Program (PPP). The \$91,500 loan has been forgiven in full.
- > Kris Johnson was hired as the new office manager.
- > Upgraded the phone system at a cost of \$5,000.
- > Continued discussions related to the acquisition of the Columbarium.
- Established an Operating Budget for 2022.

We express a sincere thank you to Pastor Perry and Pastor Brian for their superb leadership during the year. We pray for God's guidance as we venture into another year of service in God's world.

## 2021 ANNUAL REPORT - BOARD OF DEACONS

Greetings from your Board of Deacons for First Lutheran. We have been a very busy board this year trying to figure out how to keep our worship meaningful at the same time keeping everyone as safe as we possibly could. While the previous year was a challenge trying to figure out a way to move everything to outdoor and Zoom services, this year was just as big of a challenge. It was not as easy as just saying "We're open!' And everything would simply return to normal. There were many things to discuss and plan out. When would we open our building, what restrictions do we need to keep in place, how can we best keep everyone as safe as possible and is it possible to make everyone happy, were just a few of the things we needed to consider. Hopefully, with God's help, we found a way to start bringing our congregation back together. It appears to be working as each week we have seen more people back inside our walls and praising God.

Communion has always been one of the big responsibilities of the Deacons. This past year, we added communion to our Outdoor Services, which had never been done before and the response was very positive. People had missed this and we were glad we figured out a way to make it happen during our Drive In services. After moving back into the church building for services we decided to continue using the pods along with in person communion so people could chose the option they felt fit their needs.

This past year we experimented a little with our worship schedule to find something that filled everyone's needs. For a while we tried having both a Wednesday and a Saturday evening service. After studying the situation, we came to the conclusion that we we're not ready for this option so we chose to drop Saturday evening for a while and concentrate on Wednesday and Sunday services. After monitoring this schedule for some time, we opted for another change. We reinstated the Saturday evening service and eliminated the Wednesday service. As of now we are having church services on Saturday evenings and Sunday mornings, leaving Wednesdays for Youth Group, Confirmation classes and Music practices. The option of online worship is still available for all who want to use it.

The deacons have been trying to establish relationship with the other boards and organizations at First. The last few months we have been connecting with the Stephen's Ministry team at First. We have set up a schedule with them where they report in person to us twice yearly and send a written report twice. We have learned a lot about this group and all they are doing to help the people of first with some of their challenges. It is my wish that we continue this relationship and start to connect with some of the other groups in our church.

As we move forward into 2022, I ask that you continue to pray for this board. I realize that we have not always made decisions that everyone agrees with but we always try to do what is best for First Lutheran. The last two years have been a challenge but we tackled each challenge as it came our way. We continue to ask for your support and welcome your positive comments and suggestions.

## 2021 ANNUAL REPORT - DRIVE-IN WORSHIP

Because of the COVID-19 pandemic, indoor worship continued to be suspended at the start of 2021 and drive-in worship continued to be held in the parking lot of First Lutheran Church. When indoor services were reconvened, drive-in worship also continued to be offered. Starting March 21, 2021 and continuing until May 23, 2021 two drive-in services were offered at 8:30 a.m. and 10:00 a.m., in conjunction with the indoor services.

From January 3, 3021 to May 23, 2021, there were a total of 1,078 cars, which averaged 33.69 cars per service. This included a service on Ash Wednesday (11 cars in attendance) and two Easter morning services (112 cars in attendance total for the two services).

On May 30, 2021, drive-in worship moved to the regular space north of the church. We continued worshiping there until September 5, 2021. Fifteen services were held with a total of 2,663 cars, which averaged 177.53 cars per service. The largest attendance was on June 27, 2021, with 226 cars.

We were excited to resume handing out bulletins (and dog treats) and offer coffee and donuts. Communion was also served the first Sunday of each month.

A special offering was held from May 20 to September 7, 2021 to raise funds for a new building for the outdoor worship space. It was exciting that the giving surpassed the goal. God is so good! We look forward to having the new structure completed sometime in 2022.

It takes a lot of people to help make the drive-in worship services possible. Huge thanks to those who mowed and prepared the area for services, prepared the bulletins, set up and took down the electrical equipment, parked cars, handed out bulletins, handed out communion pods, made coffee, picked up donuts, served coffee and donuts, collected offering and ushered people out at the end of services. Big thanks to the musicians and Pastor Perry and Pastor Brian. They all help make the outdoor worship experience so meaningful and spiritual.

## 2021 ANNUAL REPORT - FIRST LUTHERAN FOUNDATION

The First Lutheran Foundation consists of two funds. One fund is used for future capital improvements or unforeseen needs of the church and has no limitation on the amount of withdrawal. This fund is called the First Lutheran Fund. At the end of 2021 our balance was \$110,582.

The second fund is to be used for missions. This is called The First Lutheran Endow Fund as it is an Endow Iowa fund with certain tax incentives. This fund may offer the contributor a 25% Iowa Income Tax Credit. These funds are limited to a maximum of 5% withdrawal so they truly are an endowment fund that will be there forever. The 2021 ending balance of this fund was \$182,283. \$7,000 of grants were awarded this year bringing the total grants awarded to over \$23,000 given to worthy mission projects.
